## From our Chair

# An exciting year for the Foundation as it celebrated a milestone of ten years.

It is with pleasure that I report on the activities of the Foundation for the twelve months to 30 June 2021.

The year 2021 was an exciting one for the Foundation as it celebrated a milestone of ten years of full-year activities since its inception. Looking back over those ten years it is fantastic to be able to report that during this period the Foundation has distributed a total of \$4,919,093 to Baptist Care SA, an amount that has enabled lasting change to be provided for many peoples' lives. Commencing with initial seed funding of \$500,000 from Baptist Care SA and a \$14,500,000 contribution arising from the sale of 'Playford Village' Residential Aged Care facility in 2013 the value of the Foundation has now grown to \$20,303,999.


As determined by the value of the Foundation's assets as at 30 June 2020, an amount of \$693,811 (4%) was distributed to Baptist Care SA in 2020/21. The Baptist Care SA Board subsequently directed these funds to support the work of the Chaplaincy and Church Pathways teams. Baptist Care SA's WestCare Centre was also a funding recipient (see distribution chart on page 3, and subsequent stories of this wonderful work).

Thanks to the investment guidance provided by Ord Minnett, the Foundation's investment portfolio rebounded remarkably during the year from the impact of COVID-19, achieving an operating surplus of \$3,652,525 for the year and a net surplus of \$2,958,714 after distribution to Baptist Care SA. With lingering economic uncertainty concerning the long-term impacts of COVID-19, the Board continues to give strong attention to ensuring that the investment profile remains as resilient as possible in order to face any potential future impacts.

Sadly, 2021 was also a year of loss with the passing of Rick Blake, one of the Directors of the Board. Rick served the Foundation faithfully and with professionalism, wisdom and grace. He will be greatly missed. Please see the separate item in this Report for further insights into Rick's contribution. At the time of writing, our Board is currently searching for some new Directors as we look ahead.

On behalf of the Board, I express our sincere appreciation to the Board, Management, Staff and Volunteers of Baptist Care SA for their ongoing commitment to work for the benefit of the most vulnerable in our community. I also acknowledge and thank my fellow Foundation Board members for their dedicated service and support over the past year.

I also acknowledge the generosity of our donors. Your ongoing support makes it possible to 'find ways to make lives better' for the vulnerable in our community.





## **Chaplaincy**



## Stepping up

The last year has been extraordinary. From the perspective of chaplaincy, the advent of COVID-19 has seen our Baptist Care SA Chaplains step up to the task of providing spiritual care in this complex environment.

Our **Staff Chaplain Ian Warner** played a key role in the support of staff as they coped with the rigours of lock downs and the challenges of delivering support to our vulnerable clients in this context. Ian saw an over 50% increase in the use of Chaplaincy across the entire year as staff utilised it to explore the big questions of purpose and hope that COVID-19 raised.

Our **Hospital Chaplain Paul Tyler** played a key role at the Royal Adelaide Hospital (RAH) as part of a four-person team that cared for the staff, patients and their families in SA's primary COVID-19 hospital.

Finally, our **Prison Chaplain Richard Hawke** carried the load of caring for the inmates of the Adelaide Remand Centre. He was the only Chaplain providing this vital ongoing care during the toughest of the prison restrictions. In addition, Richard tackled the challenges of supporting ex-offenders on release through the Breaking Free program.







# Easter message brings hope to inmates in Adelaide Remand Centre

Over the Easter weekend the chapel service at the Adelaide Remand Centre (ARC) was once again well attended. The men heard that Mary Magdalene had been the first person to discover Jesus's empty tomb. They were astonished to learn that she had been a prostitute.

The following week one of the inmates who had been at the service asked our Chaplain Richard if he could have a chat.

He said he was so grateful for the chapel service. He shared that his partner is a prostitute and that it breaks his heart that she should be living that lifestyle while he is in prison. He was incredibly touched by the story of Mary and had been thinking about it ever since.

Without any further encouragement, he said he wanted God in his life and he wanted God to touch his partner.

Today, he is absolutely committed to change and wants to come on to Baptist Care SA's Breaking Free post release support program.

## Together with our churches

# **Collaborative Community Projects (CCP)**

Baptist Care SA partners with local Baptist churches to engage meaningfully with the most vulnerable members of their communities though our Collaborative Community Projects (CCP) fund.

CCP funding exists to facilitate partnerships between Baptist Care SA and local Baptist churches to support the delivery of a broad range of community-informed, collaborative and sustainable community projects.

The CCP is now in its fourth round and connection and interest with CCP has been gaining momentum with an increased number of churches expressing interest in participating.

## In the most recent round, funding has been approved for the following:

- Holdfast Baptist Church
   Holdfast Hub Men's Shed 3 years
- Christies Beach Baptist Church the SAFE Centre, initial one year pilot
- Ingle Farm Baptist Church
   Ingle Farm Community Support Centre
   (including COACH) 2 years
- Grange Baptist Church Kids COACH – 2 years
- Clovercrest Baptist Church Family COACH 2 years.

We are delighted that the Kids COACH program run by Clovercrest Baptist Church has become sustainable and is continuing independent of CCP funding.

#### **STATEMENT REGARDING COVID-19**

The Directors of the Trustee Company continue to consider the implications of the COVID-19 pandemic on the financial position of the Foundation and its operational performance. The primary potential impact of the pandemic with respect to the Foundation pertains to lower or fluctuating investment returns and the value of its market investments.

The Foundation applies the fair value model to value its investments. The impact of COVID-19 had a significant impact on the fair value of investments reported as at 30 June 2020 for which a significant recovery and increase was experienced in the year ended 30 June 2021. The Directors declare that no subsequent event disclosure is warranted relative to the fair value of market investments disclosed in this report.
