From our Chair

The year has seen a growing collaboration with the Board of Baptist Care SA. We now meet together at least once a year. In addition, both Boards have joined with members of the Baptist Care SA Senior Management team to attend tailored Australian Institute of Company Directors (AICD) training to broaden our knowledge and understanding of Governance, Strategy, Finance and Risk.

The Foundation's portfolio achieved a sound financial performance. Its operating surplus was \$1,214,349 and its net surplus after distribution to its beneficiary Baptist Care SA was \$556,004.

During the year, we have welcomed two new members to the Foundation Board. Marianke Thompson is an experienced Chartered Accountant and a member of Christies Beach Baptist Church. Graham Brown, CEO of Baptist Care SA and a member of Blackwood Hills Baptist Church, joined the Board following his appointment in January 2018. We greatly appreciated the contribution made by acting CEO Michael Hynes during his time as a Director.

I extend the thanks of the Board to Ord Minnett Ltd who continue to manage our investment portfolio. We are grateful for their ongoing advice and support.

The Foundation distributed \$658,345 to Baptist Care SA in 2017/18. These funds were directed to support the work of the Church Support team, the Chaplaincy team, and \$250,000 (36%) was committed to the inaugural Collaborative Community Projects program, providing funding for dedicated projects that will assist local Baptist churches to work with vulnerable people in their local community.

On behalf of the Board, I express our sincere appreciation to the Board, Management, Staff and Volunteers of Baptist Care SA. I also acknowledge and thank my fellow Foundation Board members for their dedicated service over the past year.

Together, we are investing in creating communities of hope and nurture and finding innovative ways to break the cycle of despair and isolation.

And finally, I acknowledge our donors. Your gifts really do make a difference.

They not only enable the long-term work of Baptist Care SA, but also represent a source of inspiration to those at the coal-face who see the transformational power of your generosity.

Equipping and supporting Baptist churches

Baptist Care SA's Church Support Team is dedicated to working with Baptist churches across the state to equip and support them in their engagement with their communities.

Team members include Joanna Hubbard (currently on maternity leave), Anne Van Loon, Vicky Legge and Ellen Beasy. Together, they represent 1.6 FTE.



The team works closely with individual churches to provide tailored support, specific information and resources

Workshops conducted during the year covered topics such as domestic violence, single parenting and mental health. Baptist Care SA's pastoral health and care course 'One Another Care' was presented to members of five churches.

On 16 April, to mark National Advanced Care Planning Day, an exciting new resource 'My Choices; an A–Z of personal choices and practical preparation for end of life support' was launched. This was well received and continues to be distributed on request. The team can also provide community workshops to support the use of the resource.

The 'A-Z' aims to help people effectively navigate the consumer directed care environment by thinking through the ways in which they wish to be cared for as they age and move toward the end of life.

Collaborative Community Projects

The inaugural round of the Collaborative

Community Projects commenced in early 2018.

This exciting initiative facilitates the partnering of

South Australian Baptist churches and Baptist Care SA

to effectively mitigate disadvantage and strengthen
local community.



Seventeen churches participated in Thriving Communities workshops which explored what Community Development, from an asset based approach, can look like in the unique context each church finds themselves in.

Subsequent project applications came from churches who are already engaging with their local communities, have built relationships and are planning to continue to build on these.

They included positive initiatives such as

- strength-based mentoring of vulnerable children and families
- partnering directly with a Baptist Care SA service to provide a continuum of care by building friendships with vulnerable young people, and
- plans to facilitate connection between neighbours in areas of disadvantage.

The ongoing dialogue has enlivened existing relationships and helped form new ones. Together, we continue to plan bespoke projects aligned to specific community needs.

Chaplaincy

Baptist Care SA's Chaplaincy team worked with more than 3,000 people in 2017/18.

The team includes

- Rev lan Warner: Baptist Care SA Coordinating Chaplain, focus on staff support
- Rev Paul Tyler: Central Adelaide Local Health Network Royal Adelaide Hospital, support of patients, families and staff
- Rev Judith Carpenter: Gawler Health Service support of patients, families and staff, focus on palliative care
- Rev Richard Hawke: Prisons Adelaide Remand Centre, offender support, ex-offender mentoring and church support around working with ex-offenders
- **Rev Lesley Vince: RSL War Veterans Home** residents, families and staff, focus on building connection with Glen Osmond Baptist Church.

Work has continued to grow and break new ground with the exciting establishment of the Central Adelaide Local Health Network Staff Chaplaincy based out of the Royal Adelaide Hospital, the winning of a grant from Department of Corrections around supporting ex-offenders to gain employment and the development of new training to support staff in self-care and resilience building.
