## From our Chair

I am pleased to announce on behalf of the Baptist Care Foundation Board that the Foundation has experienced another solid year, enabling us to grow our investment funds whilst also providing a significant annual contribution to support the wonderful work of Baptist Care SA.

It's been exciting to see the progress made in Round One of the Collaborative Community Projects which supported four churches to increase connection and capacity with vulnerable people in their communities (further detail provided on page 5).

The Foundation's portfolio achieved a sound financial performance for the year. Its operating surplus was \$1,721,538 and its net surplus after distribution to its beneficiary Baptist Care SA was \$1,040,954.

A formal review of the Investment Manager relationship with Ord Minnett Ltd was undertaken during the year with Ord Minnett Ltd being re-appointed to continue to manage our investment portfolio. I extend the thanks of the Board to Ord Minnett Ltd for the expertise they bring to this important part of the Foundation's activities. We are grateful for their ongoing advice and support and together we have identified some minor refinements to continually improve our work processes.

The Foundation distributed \$680,584 to Baptist Care SA in 2018/19. The Baptist Care SA Board subsequently directed these funds to support the work of the Chaplaincy team, the Church Support team and the WestCare Centre.


Together, we are investing in building capacity within our communities to connect and engage with our most vulnerable citizens and support them to experience hope and achieve success.

# Impact Report

## Chaplaincy

Baptist Care SA has worked with around 3000 in 2018/19 through our hospital, prison and aged chaplaincies.

Our staff Chaplain supported 172 individuals through 361 issues. More than 150 staff were proactively supported through their Psychometric Assessments. Our current team includes

- **Rev Ian Warner:** Baptist Care SA – Coordinating Chaplain, focus in Staff Support
- **Rev Paul Tyler:** Central Adelaide Local Health Network – Royal Adelaide Hospital, Support of Patients, their Families and Staff
- **Rev Richard Hawke:** Prisons – Adelaide Remand Centre – Offender support, Ex-offender mentoring and Church support around working with ex-offenders.

A key focus of staff chaplaincy has been the support of teams as they encounter the challenges of working with a highly traumatised client base. This has included not only 1:1 care for individuals and teams working with difficult placements and clients, but also self-care training.

Our chaplaincy at the Royal Adelaide Hospital continues to make a difference and has found ways over the last year to bring together not just our chaplaincy expertise, but also to make links with other Baptist Care SA programs such as homelessness, to provide better support to

vulnerable and marginalised people utilising the hospital.

The Breaking Free post-release mentoring of ex-offenders continues with the successful conclusion of the Towards Employment Pathways grant from DCS which helped a number of ex-offenders be equipped to find long term employment through training and work experience.

Sadly, we saw our partnership with Glen Osmond Baptist, providing chaplaincy to the RSL War Veterans Home finish up at the end of 2018 as the RSL moved to a volunteer based strategy. We thank Lesley Vince and all the chaplains who preceded her for their generous and nurturing spiritual care in this setting.

We also farewelled Rev Judith Carpenter as she retired as chaplain at the Gawler Health Service. Judith who pioneered this role leaves us after 8 years of dedicated service which included a nomination for South Australian of the Year as the Barossa's representative – a clear testament to the respect in which she was held by her community.

## Working together with Baptist churches

The Church Support Team (CST) provides individual churches with training that equips them to effectively support our community's most vulnerable people. We provide workshops, information and resources that help churches offer helpful support, and promote quality health and pastoral care activities. We tailor what we offer to the needs of each local church. Last year the CST provided 31 workshops and forums, and presentations to 732 people.

Team members include Joanna Hubbard (currently on maternity leave); Anne Van Loon, Vicky Legge, Sophie Laguna and Ellen Beasy.

## The Heart of WestCare

The kitchen is at the heart of Baptist Care SA's WestCare Centre.

This is where our Kitchen Coordinator, Heather, devises menus, prepares and serves meals. She is supported by teams of volunteers from all walks of life, including individuals, companies, schools, universities and community groups.

Heather and her team provide breakfast and lunch five days a week, and lunch on Sundays.

They serve up to 120 flavourful, nutritious meals a day and provide a warm and welcoming environment for people to sit down and enjoy their meal.

Meals cost \$2.50 for those who are able to pay. But no-one goes hungry – everyone who comes to us for a meal, is fed.

The most popular day is Thursday when lunch is a 'three course special': a roast, along with soup and dessert. The classic roast is always a winner with our clients, and many 'save' the dessert and take away with them to have as their evening meal.

For many clients this is their only social interaction for the day.

The shopping list is long. Every week, Baptist Care SA's WestCare Centre goes through at least 50 loaves of bread, 210 litres of milk, 400 kilos of fruit and vegetables, 25 kilos of cereals, pasta, rice and 33 kilos of meat.


