From the CEO

Greetings and welcome to the 2023 impact report, and a happy 110th birthday to Baptist Care SA.

In life, work, and ministry, a tension always exists; looking backward, reflecting on the past, whilst moving forward with purpose. The 'reporting season' allows a moment of review and reflection, not only for the Board and teams of Baptist Care SA, but also for all those who have committed themselves to the vision and mission of Baptist Care SA.

Recognising that the Baptist Care SA moves forward into its 111th year, I commend this year's impact report to you.

2022-23 was my first full financial year as CEO, which enabled me a clearer view of the organisation, what we are about, and what was needed for success. I thank the Baptist Care SA team for their support, diligence, hard work, and determination to ensure the delivery of our mission.

In addition to our important daily activity, throughout 2022–23, we undertook a series of forums and roadshows to engage with our staff and volunteers, to hear their hopes, challenges, and achievements in Baptist Care SA. The leadership had an opportunity to meet face to face with the majority of our team, in the process.

It should not surprise you that the client (and client impact), the journeying with others, staff teams, our culture, and the sustainability of our organisation, were all front and centre in our conversations. We have committed to all these areas as we lead Baptist Care SA.

This financial year we have positively turned around a more than five-year downward trend on organisational financial performance. Although the financial result remains a deficit, we have made a \$3.1 million improvement in result from last year, which is indicative of the work and determination of the entire team.



To make such a positive change in one year, whilst continuing to provide important services and delivery of impact, requires focus and commitment. I want to personally thank the team for this result. The move toward sustainability has not come without professional cost and necessity for change, and I am continually impressed with the courage and faith of the team as they navigate inherently difficult transformation.

The result of ground-up and topdown engagement has commenced to create a new strategic ambition. The outcome of which will be evidenced in the next financial year. It will be clearly embedded in the vision and mission of Baptist Care SA.

For the remainder of my report, I will not mimic or repeat to you, what can be discovered in the pages of this report, I will instead share two stories that I hope will provide a window for you to view and read on, as you reflect on the place and impact Baptist Care SA has as a public benevolent institution in our community.

Miss A is a 13-year-old girl who is in our out of home care where she is supported by our capable team. She has had it tough yet has hopes and visions for her future. One of those is perhaps to be the CEO Baptist Care SA when she grows up. We arranged a time for her to come and chat with me and she came to meet me accompanied by one of our Care Pathways team members.

She brought a list of questions ranging from, what did I study, through to, what is it really like to be CEO.

She also threw in a trick question; does she need to keep going to school? Yes, was my definitive response.

During the chat, the team member asked her why she wanted to be CEO. Her answer was profound. "You are all role models for me, and maybe one day, as CEO, I can be a great role model for other children in the care of Baptist Care SA".

During the year we held a camp at Mylor for children in our care and in the care of the Department of Child Protection. I went out with a couple of the managers to see how it was going. On arrival there was quite a ruckus as apparently our arrival had caused a stir. It was at lunch time and word got around that the CEO had arrived. It was the children and young people that were talking about it, not the staff.

Several young people came over, fronting up and asking all sorts of questions, telling me about the camp and about their home life, practical questions like, when and for how long they could have the internet on.

One 11yo girl, Miss J, came to me saying "Right, you're the CEO, just the person I wanted to speak with".

From the CEO continued

As I engaged in conversation, two things immediately struck me, how do 10–14-year-olds even know what a CEO is and why are they so keen on speaking with me, seeking me out, passing the word around, and coming over. When I asked one of our leaders, why the interest, she replied without hesitation, they wanted to know the person making decisions about their life and to meet that person. I was dumbstruck. Whether or not I am making those decisions, it was a heart wrenching moment.

I challenge myself and the team to remember why we do what we do. As leaders, we are continually presented with problems, issues, difficulties to solve and overcome. In meetings on financial performance and business efficiency, program and partner reviews, it is all too easy to forget that the reason we are here and everything we do is for the Miss As and Miss Is.

Our vision has a resounding focus as a life transforming organisation that is engaged in client focused care. The two stories I have shared illustrate how we need to stay client focused, and that what we do is noticed and matters. I hope you are encouraged and challenged, as I have been, as you reflect on these as you read through our report.

Baptist Care SA continues to be an important participant and contributor to the well-being of SA and its communities. I commend Baptist Care SA and its whole team from frontline staff to Board to you.

A special thanks to Julie Lawrie who handed the baton of Board leadership over to Chris Partington during the financial year. A thank you from me personally to Julie for her leadership and support, and the ongoing support and leadership of Chris Partington as Chair and the whole Board.

Aboriginal Services

'Padniadlu wadu – Let's walk together in harmony' Kaurna Elder, Uncle Lewis Yerloburka O'Brien.

With the guidance of Aboriginal Elders, Baptist Care SA provides respectful, culturally responsive services for Aboriginal people. Baptist Care SA partners in the Toward Home Alliance with Lutheran Care, Mission Australia, The Salvation Army, Sonder, Aboriginal Family Support Services, the Hutt Street Centre and South Australian Housing Authority and partners with Junction Housing and Carrington Cottages.

Wardli-ana

Connects Aboriginal and Torres Strait Islander people who are experiencing, or at risk of, homelessness with mob, culture and community. Case management, advocacy and support is provided for people living in the city of Adelaide and the southern region.

988 people supported.

Bowden Lodge

For Aboriginal and Torres Strait Islander men who are experiencing, or at risk of, homelessness, in partnership with the Exceptional Needs Unit and the NDIS.

5 people supported.

Narungga House

For young Aboriginal and Torres Strait Islander men who are experiencing, or at risk of homelessness. Narungga House is part of Aboriginal Family Support Services.

18 people supported.

Olga Fudge House

For Aboriginal and Torres Strait Islander women aged 15 to 25 and their children who are experiencing, or at risk of homelessness. Olga Fudge is part of Aboriginal Family Support Services.

27 people supported.

Deadly Pathways



Community Connections

Bean Buggy is a mobile coffee van where Flexible Learning Options students can train as baristas as part of an accredited course in customer service and food handling.

As well as practical hospitality skills, students build confidence and independence and achieve accreditation towards their SACE.





Church Pathways

Baptist Care SA is an affiliated ministry of the Baptist Churches of South Australia.

Coach mentors

Training church community volunteers to become Coach Mentors and equipping churches to support people experiencing challenging life situations.

34 mentors trained.

2022-23 focused on providing resources and support to equip churches to be more inclusive of children and youth living with disabilities, and their families.

Disability

Ensuring equal opportunities, inclusion, and empowerment for those with disabilities.

As a registered NDIS provider, we provide professional disability services spanning Improved Daily Living Skills, Developmental Education, Positive Behaviour Support and Supported Independent Living.

In 2022-23, disability services moved from Wayville to Salisbury. With easier access to public transport and greater access to parking, the service increased its connection with clients while maintaining its service to community. The team's skills, capabilities and competence continued to flourish and saw services mature and grow. This was evidenced when the service achieved the NDIS full-term audit with no major or minor non-conformances.

Everyone deserves a safe place to call home.

Baptist Care SA believes that safe, secure and affordable housing is a human right. We work with Lutheran Care, Mission Australia, The Salvation Army, Sonder, the Hutt Street Centre, South Australian Housing Authority and Aboriginal Family Support Services as part of the Toward Home Alliance; and partner with Junction Housing and Carrington Cottages to give hope; and prevent, and end, homelessness.

Baptist Care SA's WestCare Centre is a safe place where people from all walks of life are welcome. Baptist Care SA staff and volunteers work together to provide those of our community who are experiencing homelessness, loneliness and social isolation with a safe space. We offer essentials such as meals, shower and laundry facilities, and overnight accommodation during extreme weather events as well as connection to essential services.

REPORT OF THE INDEPENDENT AUDITOR ON THE SUMMARY FINANCIAL REPORT TO THE MEMBERS OF BAPTIST CARE (SA) INCORPORATED

Opinion

The summary financial report, which comprises the summary statement of financial position as at 30 June 2023 and the summary statement of profit or loss and other comprehensive income for the year then ended, and related note, are derived from the audited financial report of Baptist Care (SA) Incorporated for the year ended 30 June 2023.
